Proposed Action

Alternative 2

Alternative 2 gne e tute land-base training wool Tinian usuul kapasal loll Alternative 1, iiwe tempo gnere agnuul ebwe schagh torri 5 percent wool ngere igha No Action Alternative. Akauul imwal ngere leliyel training ischagh me meta emak fale Alternative 1.

Key Environmental Impacts

Minimizing Public Access Restrictions: Loll yar mataf ren malware yar tolap tolong towow me wool ngere sowbol falieu igha Militad e amwuschuu, Marine Corps re angaang me' CNMI leadership bwe live-fire ranges me' yeli training concepts ka ebwe mwai uu ngenirr towlap towow tolongol sowb kei. Rele inetena rebwe uurr, Falieu ngere sowbb ka ello fele militad rebwe tiling tuu loll 8 training areas, bwe ebwebwaang towlap le tolong towow lol sowb igha essor uurr ngere training activities. Bulul ghatchurr me' amalauw, loll akewl training ngere uurr ebwe mwaang towlap le tolong towow. Fale akew uurr ngere re training nge rese aiuur lo towlap le tolong towow bwerebwe torri uurr wooll meschengei se't me' lelieyerr tourist (Wool Ushi ne' Tinian North Field National Historic Landmark) Towlap emwaan rebwe torri ngere igha mo re ke training ngere uurr.

Range Control: Aleghul malawerr training unit me'towlap loll uurr ngere training events, an on-island Training Area me' Range Operations Command (Range Control) rebwe ferri ngre aiuu. Range Control ebwe schedule lill training me' coordinate fegnan me' officials me' towlap, Ayora ngere ferri advance notifications bwe towlap ebwe tawa loll mweileleyiin mmalawerr. Arrongrong gnenirr towlap rebwe lol me'updated in real time nge illa gne towlap rebwe tawe tolong towow loll Military Lease Area. Biological Resources: Proposed Action referri bwe ebwe attawai ngere aghitighita direct impacts ngenil ngere woorr species ka etel fale federad. Achuurong meren training me' construction nge temporario, eghus me' eghuus, me' essorrol emwaan ebwe buuliew liewel loll behavioral me' physiological ngenirr Painschey ngere Mariana fruit bats. Esowb amweii nge ebwe schiewloo yew raan mwetengeni muchelol raagh yey. Consultation fengen me' U.S. Fish and Wildlife Service wool ren Section 7 ren Endangered Species Act eschewl pending.



Cultural Resources: Section 106 ren National Historic Preservation Act ill 1966 require liir federal agencies bwe rebwe consideralil towowuul yar undertakings wool historic properties. Marine Corps loll yar angang longl loll Section 106 ill National Historic Preservation Act, raa collaborated me' consulting parties, tute CNMI Historic Preservation Officer me' Advisory Council wool Historic Preservation, le aghitighiti suughuuwal training wool historic properties ill Tinian me' nganerr towlap yar tolong towow wool historic properties.
